

FEM RESPONSE TO COVID-19

The worldwide spread of COVID-19 is an unprecedented event which requires all of us to adapt quickly in order to protect ourselves and our communities.

This note serves to provide you with an overview of how FEM is dealing with the pandemic. Our response is premised on the desire to keep all stakeholders safe while also ensuring the continuity of our business which has proudly served the construction industry for more than 80 years. We are actively following the instructions and recommendations of the South African Government, South Africa National Department of Health, The National Institute for Communicable Diseases and the World Health Organisation.

1. ACTIONS WE ARE TAKING

- We have set up a Covid-19 Task Team. This is a multidisciplinary team with people from different parts
 of the business that is assisting in co-ordinating and continuously reviewing our response to this
 pandemic.
- We have put together a Pandemic Response Plan which will ensure that we are able to respond proportionally based on the specific scenario facing us. This plan will be constantly reviewed by the Task Team based on updated and relevant information.
- We are continuously educating our employees on measures to protect themselves from the pandemic.
- We are allowing our employees to work from home where possible.
- We have halted all air travel and any non-essential business travel.
- We have increased the frequency of cleaning within our offices.
- We are encouraging the use of videoconferencing or telephones to conduct meetings that cannot be postponed.
- Specific protocols have been put in place for those who visit our offices.

2. CONTINUATION OF OUR SERVICES

We are taking all appropriate measures to ensure, safely and securely, continuity of our operations and the provision of a good service to all of our clients and stakeholders.
